

Pennsylvania Outdoor Life Sweepstakes

OFFICIAL RULES

Eligibility. Subject to the additional restrictions below, the Pennsylvania Outdoor Life Giveaways are open to residents of **["48 contiguous States"]** who are 18 years or older at the time of entry.
